## **PROFIT WARNING**

This announcement is made by Expert Systems Holdings Limited (the “**Company**”), together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on Growth Enterprise Market of the Stock Exchange (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Future Ordinance (Chapter 571 of the Laws of Hong Kong).

The board (the “**Board**”) of the directors (the “**Director(s)**”) of the Company wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that based on the information currently available to the Board, the Group is estimated to record a substantial decrease in net profit for the three months ended 30 June 2017 (“**Q1FY2018**”), as compared to that of the corresponding period of 2016.

As reported in the annual report of the Company for the year ended 31 March 2017, the market conditions and economic outlook remain weak, which cast uncertainty on the overall demand of the Group’s customers for IT infrastructure solutions. The estimated decrease in net profit for Q1FY2018 is mainly due to the decrease in gross profit margin during the period as a result of the Group’s efforts in maintaining its market share by offering more competitive pricing under the challenging business environment.

The Company is still in the progress of finalizing its unaudited consolidated results for Q1FY2018. The information contained in this announcement is only based on the preliminary assessment by the Board with reference to the information currently available as aforementioned, which has not been reviewed by the audit committee of the Company, and is therefore subject to change and adjustment. Shareholders and potential investors are advised to read carefully the quarterly results announcement of the Company for Q1FY2018, which will be published in early to mid-August 2017 in accordance with the requirements of the GEM Listing Rules.
